



Wedding Contract

Congratulations on your engagement and thank you for choosing Estilo Salon! For the most important and most photographed day of your life, trust the wedding professionals at Estilo Salon. We specialize in making your day the most relaxing and glamorous day of your life.

To move forward in reserving appointments at Estilo for your special day, a few things will be needed. We ask you download and print our pdf contract from estilo-salon.com under services/wedding. You can also pick these forms up in salon. All information requested must be completed prior to an accepted Estilo Salon booking. A valid credit card on file is required to reserve your wedding day appointments. If credit card expires prior to your wedding date, you will be required to update it prior to provided services at Estilo Salon.

A one-week notice is required for cancellation of any bridal party appointments. The credit card on file will be charged for payment of any appointment changes or cancellations after the cancellation deadline. Please let your Estilo scheduled wedding guests know of this policy.

One week prior to your wedding, Estilo Salon will check in with you to verify your wedding party's appointments. If you do not confirm with us and completely no show, your credit card will be charged the full cost of all appointments scheduled.

Our wedding contract ensures that Estilo Salon will make you and your party top priority the day of your wedding. It is recommended that all scheduled bridal party arrive 15 minutes prior to their scheduled appointments. We are not responsible for any service rendered if the guest is late. If possible, have your entire party arrive at the same starting time with clean and dry hair, wearing button-down shirts. It will cause scheduling problems and cost more if the stylist must wash and dry the hair prior to the service.

You're encouraged to invite your photographer and videographer to the salon to capture the beginning of the day excitement. You are also welcome to bring in food and drinks to enjoy.
